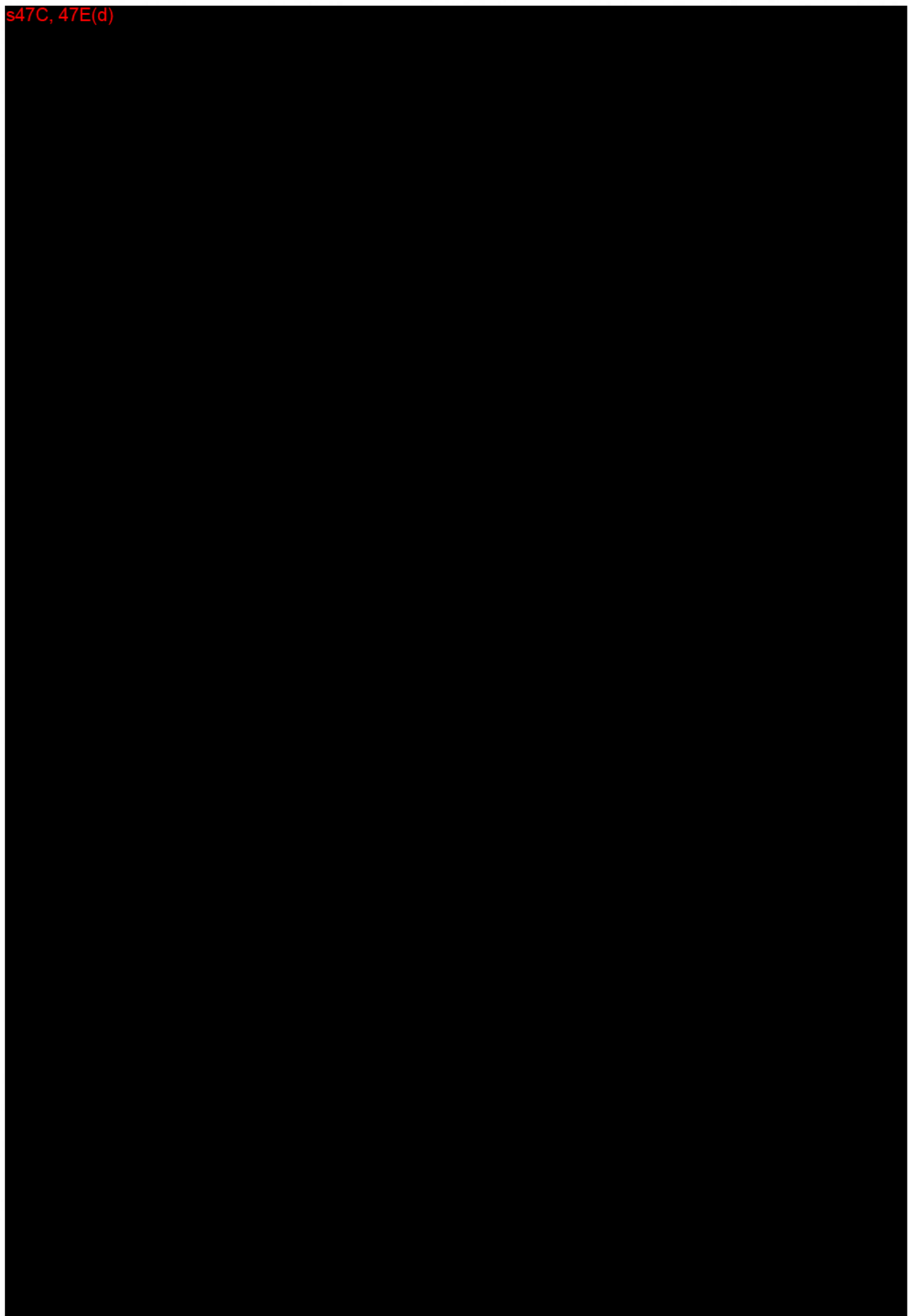

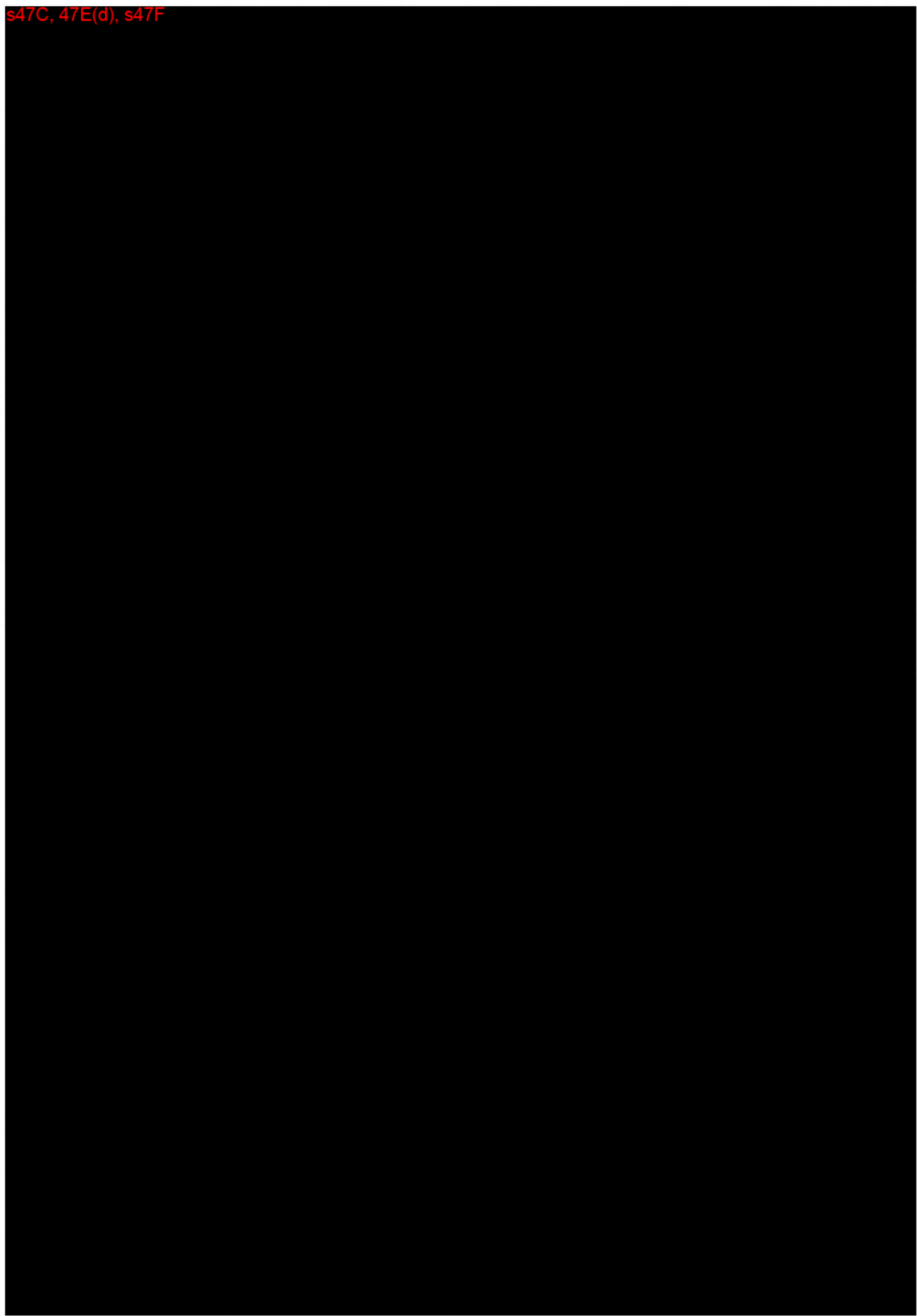
The minutes of Examiners' Meeting 2/2022 were reviewed.

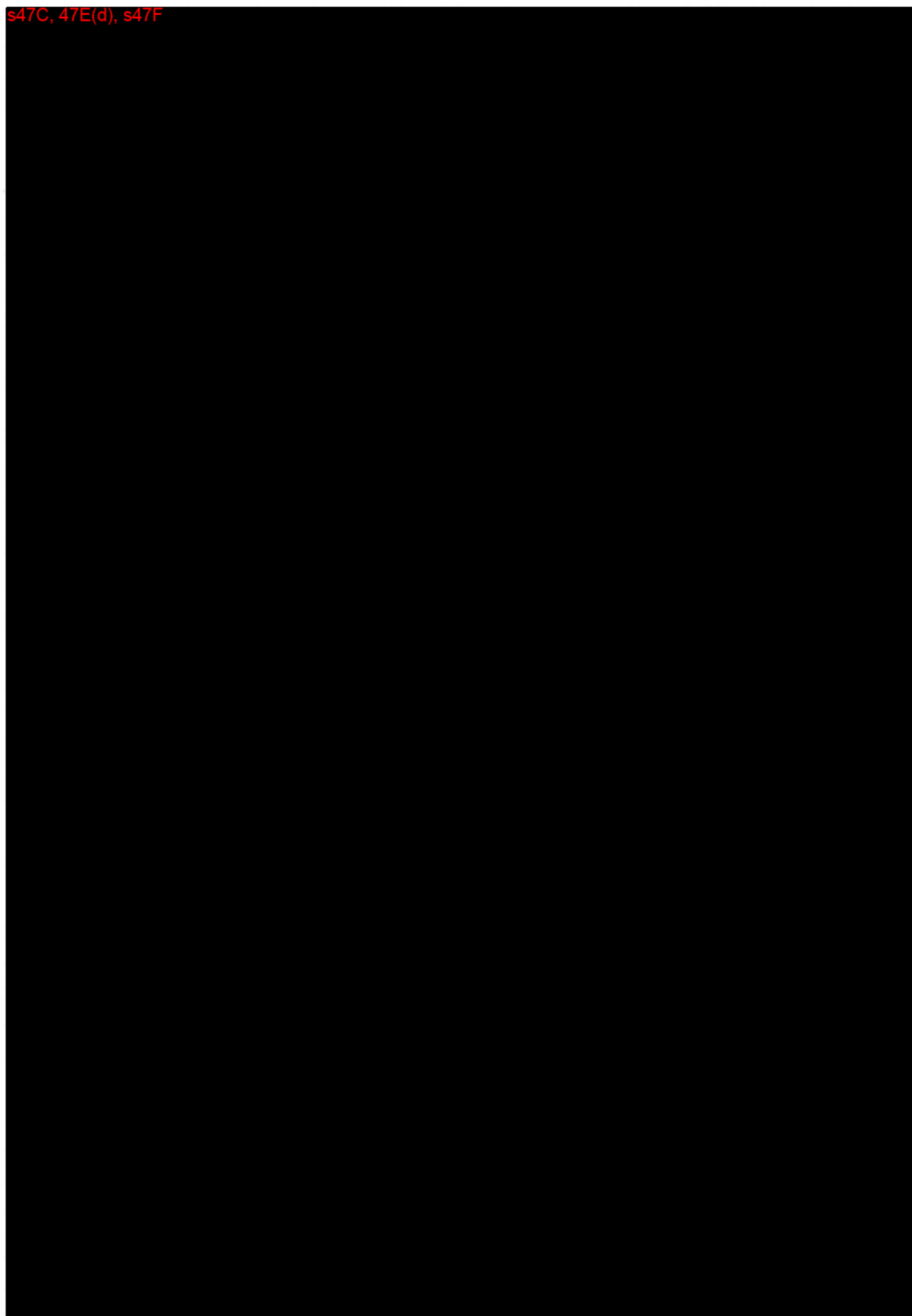
Anne McNaughton moved that the minutes be accepted which was seconded by Jo Ford. The meeting approved the minutes.

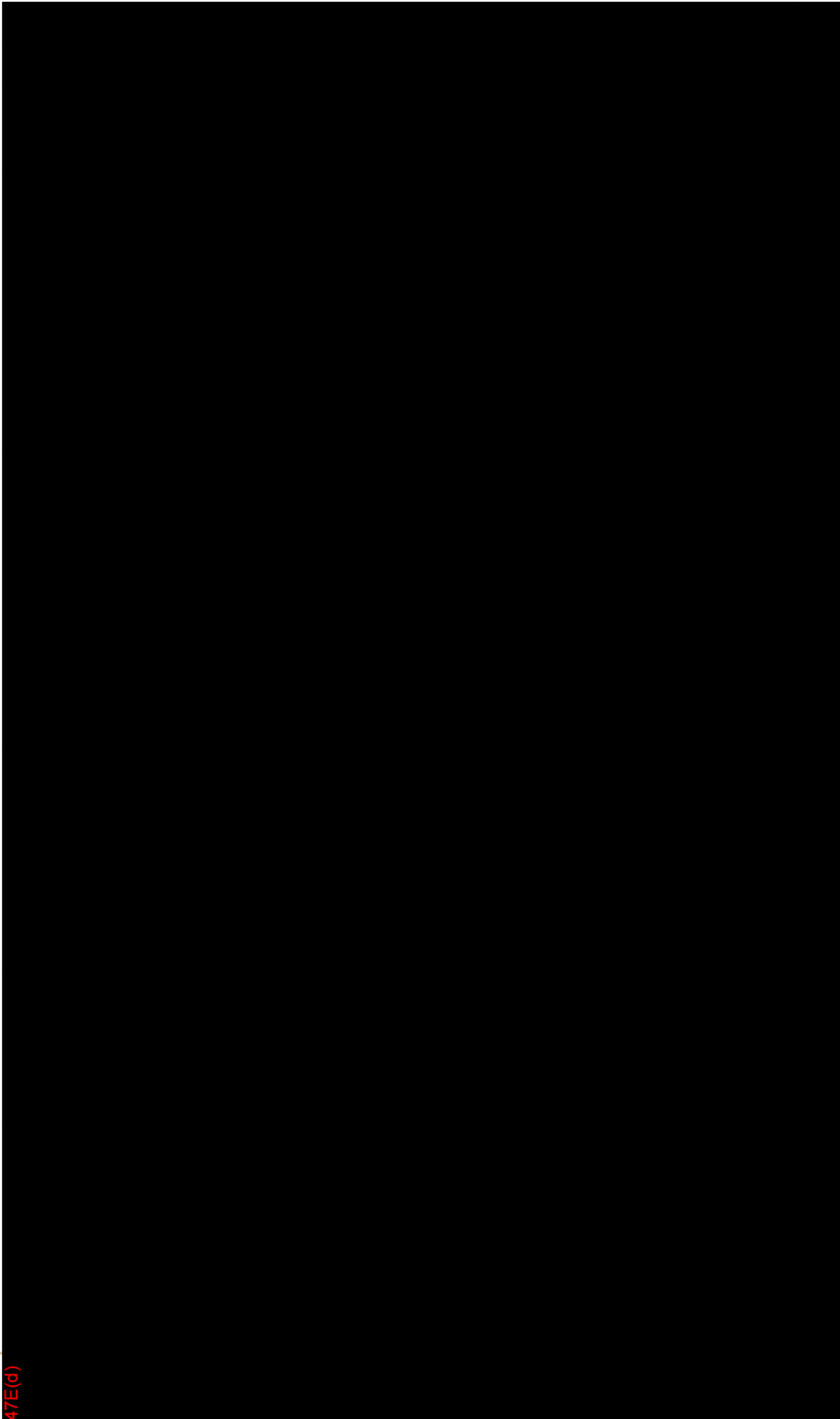


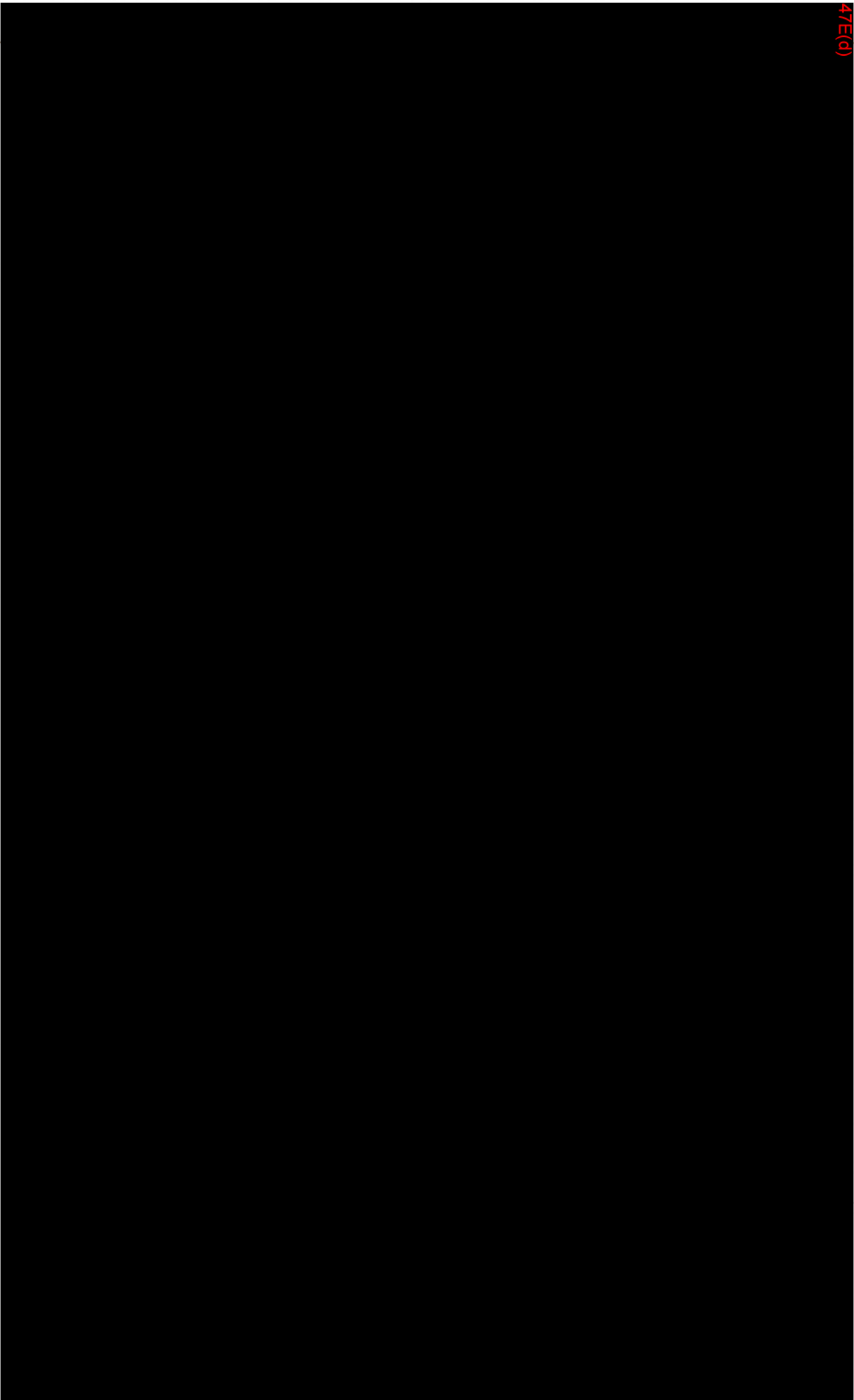


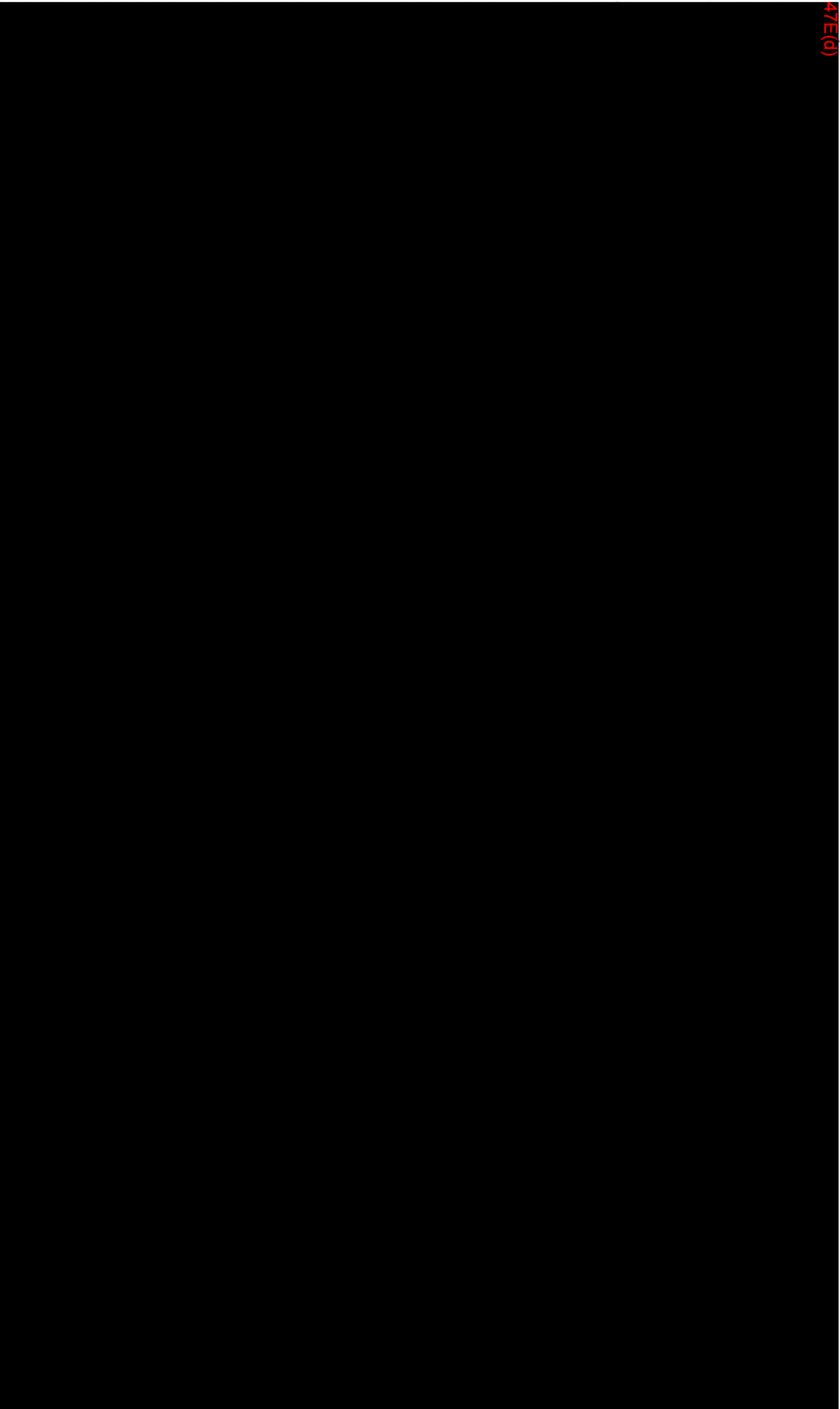


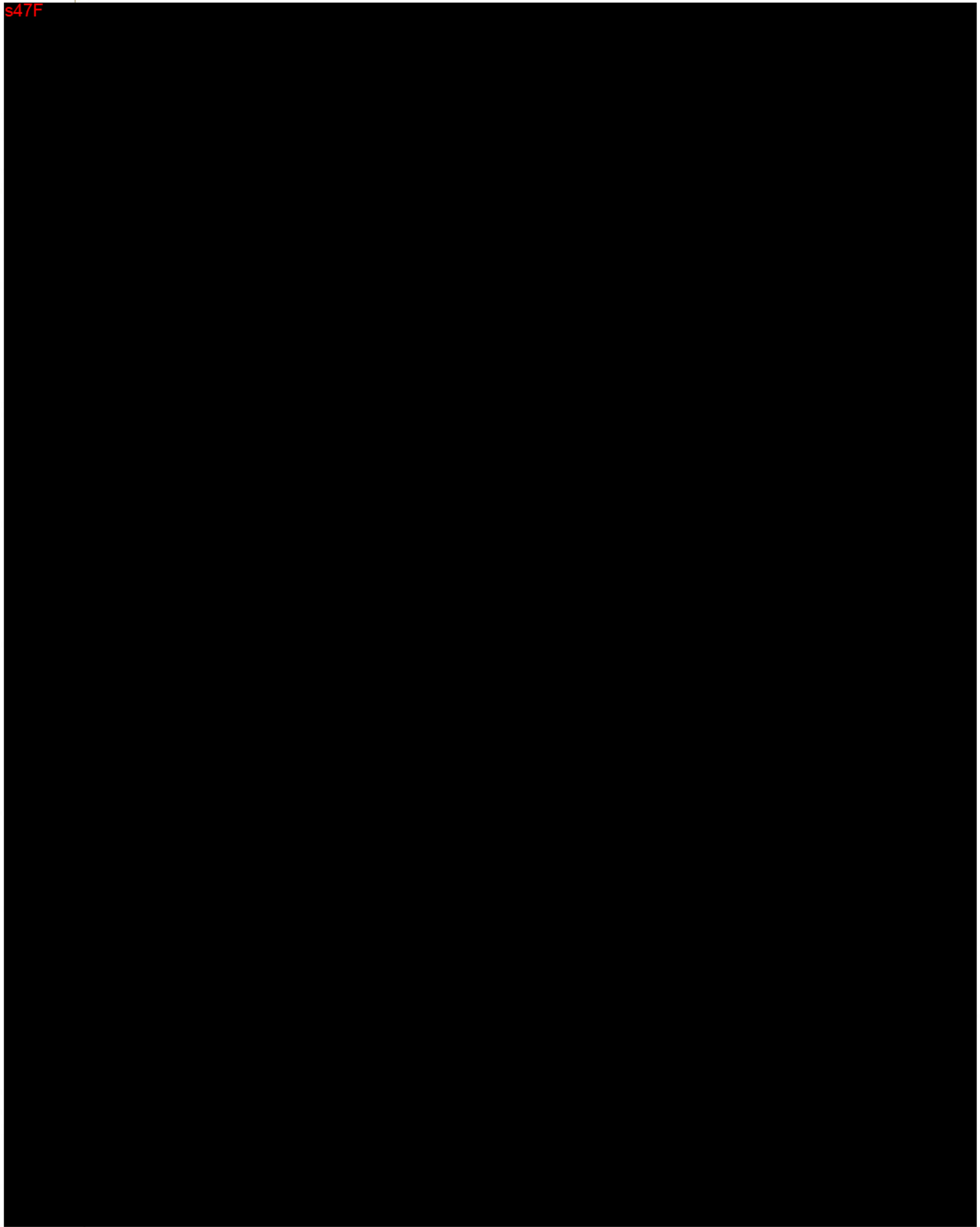


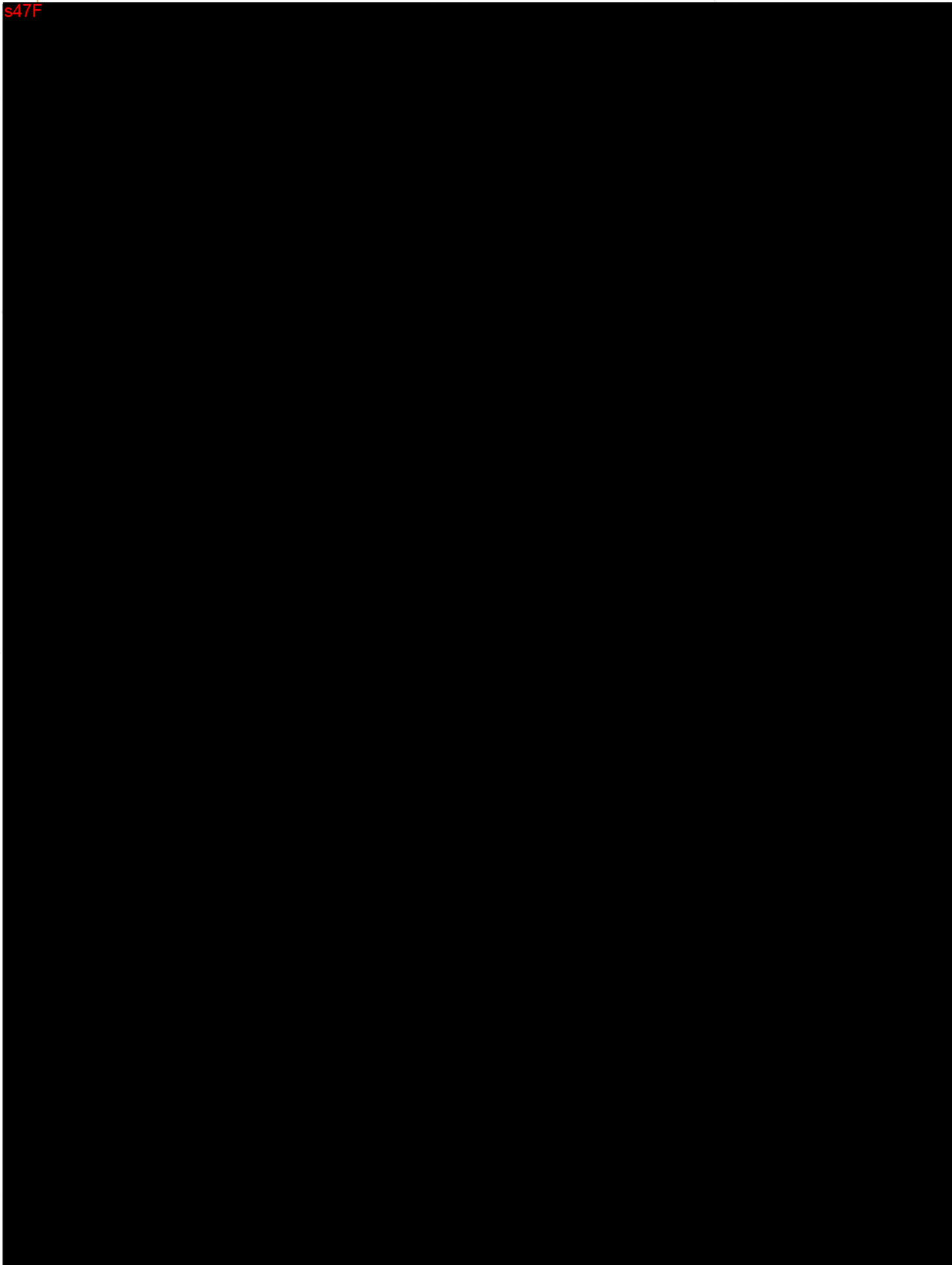












9. Medal Recommendations
