

Thank you for your email and sharing your views about the encampment on our campus. We welcome feedback.

ANU is a place of respectful debate and we are proud of our long history of student political engagement. All staff and students are free to express themselves in line with the University's Code of Conduct and Australian law. We understand that our diverse staff and students have different views on the situation in Gaza and Israel and other parts of the world and welcome those views being respectfully expressed.

To be clear, we have not asked any students to stop protesting, they may continue to respectfully and peacefully protest.

We have asked students to leave the encampment due to health and safety issues for the encampment participants themselves and also the wellbeing and safety of others. We have made this very clear to the students in the encampment.

The Vice-Chancellor invited the encampment students, through an email address provided by them, to nominate three representatives to a meeting for an open discussion. There was no response to the email, no representatives were nominated and no-one turned up to the meeting. We followed up in person and one person at the encampment said they couldn't decide who would be their representatives.

Our campus is a place of work and study for more than 25,000 people and a home for more than 6000 students. Many people in our community have told me they feel unsafe, disrespected and unwelcome on campus due to the encampment and they are not able to go about their work and studies. The encampment is dividing our community and disrupting our core functions.

The University is also committed to its <u>Socially Responsible Investment Policy</u> through which we aim to avoid investment opportunities considered to be likely to cause substantial social injury. We strive to remain a leader nationally and internationally in working pro-actively as an active asset-owner, creating a greenhouse gas neutral future as well as promoting strong social and governance practices.

The University's Investment Office reports to the University's governing authority, Council, through Finance Committee on assets held and contradictions to the policy. The current ANU Student Association (ANUSA) President and the ACT NTEU President, both active protestors, are members of the ANU Council. They are able to raise relevant concerns about ANU investments through our regular governance processes. We don't understand

why they have not done this.

The wellbeing and safety of our people is of utmost importance, and we will work to maintain the good order of our campus and the social cohesion of our community. I hope that this information is helpful to you.

Dear Vice Chancellor and ANU Executive

We write in relation to the student encampment and the four demands concerning the

situation in Gaza that are directed to the ANU, (and the fifth that is directed to the Australian Government calling for corrective action in relation to Israel and Palestine).

We note that you have not discussed these concerns with the students at the encampment and those supporting the protest.

We urge you to sit down and talk in an open and constructive manner.

We believe as bright, thoughtful and moral young people that they have an important message to communicate to you and to our community.

Students are the "canary in the coalmine" and universities have historically played a critical role in harbouring and fostering ideas of truth, objectivity, morality and human liberation.

Human progress is never made by people who accept things as they are, even if they are wrong because it is too difficult or career limiting to challenge the powerful.

As an organisation promoting peace, we also support the students demand that the ANU divest from all arms companies, and disclose all investments by the university

The situation in Gaza almost defies description in the scope and scale of its horror.

Nothing justifies the inhumanity of the wholesale destruction of Gaza or the slaughter of civilians - nor the 76 year history of dispossession and oppression of the Palestinians.

Ultimately justice will prevail as the world becomes aware of the actual facts of the displacement and oppression since 1948 in Palestine.

It is important that the university take no action to impede peaceful, if at times uncomfortable, debate on critical issues of morality and power.

We understand that seven students have been notified of disciplinary action if the encampment is not removed.

The initial reasons given were damage to the lawns and disagreeable smells from the camp. We understand that the most recent reasons given were concerns for the well being of all students, which we certainly share.

These reasons are ludicrous and unfounded when compared to the grave, indeed horrifying, circumstances of the Palestinians and the peaceful nature of the encampment.

We also note the rising clamour from the right wing press and political pressure to close down the protest by forcefully demolishing the camp. Those representatives of the press, and the Israeli lobby, would no doubt prefer that the public focus be on the claims of anti semitism, which we reject as false, rather than the horrific genocide happening in Gaza.

Further, we note that the University of Sydney VC, Mark Scott, is reported as saying that chants such as "intifada" and "from the river to the sea" do not cross the line into hate speech, and that universities "must be safe and responsible bastions of free speech". We ask that you take the same approach.

We urge you not to take the path of repression - for the sake of the students, many of whom we have met, for the sake of the university and its reputation, and for the sake of the Palestinians suffering almost indescribable horrors.

Please stay on the right side of history.

Remain an institution that promotes free expression and allows protest against injustice.

We would like to meet with you urgently as a community group with close ties to the ANU to further discuss these issues.
