





Dear Professor Genevieve Bell,

We are writing to you to request an urgent meeting to discuss the serious and worsening matter of antisemitism on Australian university campuses.

We have written to you previously, in the capacity as co-chairs of the Parliamentary Friends of IHRA, regarding the adoption of the IHRA definition.

As students are returning to campus, we would like to get a greater understanding of the Australian National University's action plan to address reports of antisemitism on its campus and ensure students are appropriately supported.

In July 2023, ZFA and AUJS conducted a survey that found almost two-thirds of Jewish students reported antisemitic incidents and more than 50% said they had hidden their Jewish identity at some point. This is a worrying problem of great concern to us.

Before the summer break, the Member for Wentworth surveyed nearly 200 students, some from your university. Their accounts highlighted feelings of fear, being targeted, and reluctance to openly express their Jewish identity. They also described the rise of antisemitic incidents including social media posts from their peers, Nazi symbols being graffitied on campus buildings and disregard for Jewish grieving in the days following the horrific October 7th attacks.

At ANU, the survey documented four accounts of alleged antisemitism on campus. We have provided these testimonials below.

The Member for Wentworth has also had three students approach her struggling with antisemitism on the ANU campus, students who report they have not yet had an effective response from the university.

We would like to urgently arrange a meeting with you to discuss the concerns that students have raised and actions that ANU plans to take in response to these reports of antisemitism.

Australian National University – Cases of alleged antisemitism

- Awful hate directed towards my daughter and her friends. They've had to be provided with a safe space by authorities so that they can study apart from the general population.
- I have had people chant their support of Hamas to my face and make extremely antisemitic comments about me and my family, seen people rip down hostage posters on my campus and abuse those putting up the posters.
- The Socialist Alternative Society has been frequently vocal about its anti-Zionist status. They harass students who look Jewish, who are wearing Kippot or Magen David's, and rip down posters of kidnapped hostages or write antisemitic tropes over the posters. They constantly comment in student association meetings (you're using antisemitism claims to push your right-wing agenda). A woman (separate occasion) spat on my friend who was putting up posters and told them to 'die you fucking Jew'
- Jewish Student voices have been targeted and neglected mostly by student unions. Student associations such as the ANU Students Association have been completely silent on Jewish issues. Silent on the October 7 massacre. Silent when Jewish students have contacted them on concerns for their campus safety. Silent when Jewish students have had friends and family who have been killed, taken hostage or are still under threat by HAMAS. Students across campus hide behind the slogan "anti-Zionism doesn't equal antisemitism". However, incidents against Jewish friends of mine such as being spat on or having property damaged occurred almost immediately after the student association's pro-Palestine events which inherently makes anyone a villain who supports a Jewish state in any form that isn't Palestine from the river to the sea. Such events include using OUR student funds to buy materials for pro-Palestine sign making and saying that students need to attend pro-Palestine protests in order to not be a racist.

BACKGROUND

- The event is taking place at the request of the MPs to discuss the "serious and worsening matter
 of antisemitism on Australian university campuses", student concerns students and to hear about
 ANU plans for response.
- The MPs are co-chairs of the Parliamentary Friends of the International Holocaust Remembrance Alliance (IHRA).
- Universities Australia met with Mr Leeser this week and reported he was respectful and constructive. He made the point that universities have gone to great lengths to support indigenous and LGBT students but won't do the same for Jewish students.
- The MPs have previously corresponded with ANU about adopting the IHRA definition of antisemitism:

"Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."

- ANU has provided Jewish students with an optional safe space on campus since the escalation of conflict post October 7, 2023. (Access has been available since 30 October).
- The Director University Experience is meeting regularly with the Australasian Union of Jewish Students ANU representatives.
- A Harmful Behaviours Disclosure Tool was introduced Semester 1 2024 to enable reporting of unacceptable behaviour including antisemitism.
- ANU executives attended the Antisemitism Workshop (university roundtable) arranged by the Executive Council of Australian Jewry on 8 April.

NOTABLE PUBLIC COMMENTS BY THE MPS

Leeser:

- "The idea that young Jewish Australians do not feel safe getting an education is anathema to me. This moment profoundly matters for our entire country, because if any Australian student cannot feel safe on an Australian campus because of the religion they hold, then our universities are failing the principle test of character."
- "The conflict in Gaza is the thin veneer or the excuse to protest the presence of Jewish students and staff. In coming months, these protests will take full flight during university open days, because these protests are not about Gaza, they are about making young Jewish Australians feel unwelcome on Australian campuses. It is pure anti-Semitism."

Spender:

• "These encampments are only further escalating the sense of fear among Jewish students and are exacerbating an already tense atmosphere. Some of the speeches and social media posts are antisemitic or at least deliberately inflammatory."

• "I call on the Education Minister and the Universities to make it clear that they do not support these encampments and they will ensure that our universities are safe and inclusive for all students, because that is not currently the case for Jewish students."

Burns:

- "This is escalating. It's becoming increasingly violent and tensions are rising. Someone is going to get seriously hurt, or worse. Police need to step in." (7 May in relation to the Monash encampment).
- "We know that the encampments are predominantly made up of non-students, and universities should take a zero tolerance to anyone not from the university harassing or vilifying students."
