Dear 47E(c)

As discussed on the phone yesterday, the ANU has been put in the unfortunate position of needing to remove the ANU Protest Encampment due to a health and safety risk, namely it's location is the location of an emergency evacuation assembly area for numerous buildings in the Kambri Precinct including a residential hall of over 400 students.

The assembly area had previously been noted and alternate assembly areas were designated, but during a fire alarm evacuation last week of the residential hall and the cultural centre the alternate assemble areas failed resulting in what has deemed to be an un-acceptable risk to student and staff health and safety.

It is was therefore decide that the Protest Encampment needs to be removed.

The students of the encampment have elected not to compromise with the university on their demands, despite the Vice Chancellor (VC) indicating on Friday 24/05 that she would be taking the matters to council next month, and therefore will not be packing up their encampment like other universities in other states have done when receiving similar VC action.

Without a voluntary pack-down we are left with no choice for the safety of the university, it's staff, students and visitors but to remove the encampment by university directive.

As we discussed Friday or intent was to act today, but as we understand we may need the support of ACT Policing, therefore as agreed we are holding our action till Monday 27/05 at 8:00am, to enable you time to be able to plan and support our action as you deem appropriate.

Normally we only have between three and ten students (with the average being five) remain overnight in the tents and they confine themselves to two to three tents, the rest of the tents are just for show. Therefore we are planning for that number in the morning. We are of the opinion that the students in the camp in the morning will comply with the lawful direction to move, due to the possible student disciplinary action under the student code of conduct that may occur if they do not comply with the lawful direction of an ANU Officer. If they fail to move and vacate as directed then we may need AFP assistance to move them on, but we are hoping that the involvement of the AFP will not be required but are planning for that possibility.



Thank you for taking the time to speak with me and your two colleagues at ANU this afternoon about the encampment. First, thank you for your support to ensure that our students are first and foremost treated with respect as we look to ensure our campus community is safe.

I believe we have a shared understanding of our objective here: to peacefully remove the encampment from the Kambri lawns to ensure the University can access a primary fire evacuation point. As discussed, I understand:

- * The AFP has requested an extension of the encampment occupation of the site until 12pm, Tuesday 28 May. This is to ensure the AFP have adequate time to put in place additional plans and contingencies, and resources to support the removal of the encampment with an eye to your prior experience with protesters.
- * The AFP has issued a directive for students to depart at 12pm, Tuesday 28 May, in line with the University's directive issued today, Monday 27 May, for the students to vacate this site due to safety concerns.
- * The AFP will be available and on the ANU campus on Tuesday 28 May to support the decampment of the students in Kambri.
- * ANU Security will provide additional resourcing overnight to ensure the risk of the continued occupation of a primary fire evacuation point is appropriately mitigated. As discussed, this is short term and unsustainable model.
- * Both ANU and the AFP share a strong commitment to de-escalating the situation in Kambri in a manner which is peaceful and respectful for all people involved.

ORDER TO VACATE - KAMBRI TENT ENCAMPMENT

This notice is to inform you of an immediate and non-negotiable directive concerning the tent encampment currently situated in the primary fire evacuation zone for Kambri.

On the 21st of May 2024 at 12:50 PM, a disruptive fire evacuation revealed a serious safety concern affecting the good order on campus and in that zone. The encampment's continued presence in this critical area poses an unacceptable risk to the safety and security of our staff and students.

The University's Council has power over the entire control and management of the University. The Director, Facilities and Services has been delegated campus-wide powers to operationalise this responsibility. As such, and in my role as Director of Facilities and Services, under the delegated authority to maintain good order on campus, it is necessary to issue this order for the immediate removal of all tents and encampment structures. This order includes the power to issue eviction notices and, if necessary, to call in the Australian Federal Police (AFP) to enforce compliance.

Effective immediately, you are required to pack up and remove all tents and encampment materials. Non-compliance with this directive will result in further action, including potential involvement of the AFP to ensure that the order is carried out.

I understand this directive may cause inconvenience; however, the safety of our university community is our top priority, by ensuring the ongoing maintenance of good order on campus.
