

# RANZCOG WOMENS HEALTH PRIZE CONDITIONS OF AWARD

#### 1. INTRODUCTION AND RECOGNITION

Each year the School of Medicine and Psychology may offer one prize known as the RANZCOG Women's Health Prize.

The value of the prize is \$500

The prize will be on offer from 2024 to 2027

The prize sponsored by the Royal Australian and New Zealand College of Obstetricians and Gynaecologists (RANZCOG). RANZCOG has instituted this prize to help motivated, highly performing medical students to consider Obstetrics and Gynaecology as a long term career choice.

#### 2. ELIGIBILITY

The award is available each year to a Doctor of Medicine and Surgery (MChD) student who:

- (a) is enrolled in Year Four of the MChD at the School of Medicine and Psychology;
- (b) obtained a Higher Level Performance (HLP) result in all Women's Health written and practical assessments.

## 3. SELECTION AND CONSTRAINTS

The members of the Selection Committee shall be drawn by the Professor of Obstetrics and Gynaecology and include appropriate representation from the Department of Obstetrics and Gynaecology ANU Medical School.

The prize shall not be shared.

If, in any year, no student is assessed by the Director of the Medical School acting on the advice of the Selection Panel as sufficiently outstanding, the prize shall not be awarded in that year.

#### 4. RECIPIENT OBLIGATIONS

The awarding of a prize is based on the information provided to the University. A prize may be declined by the recipient once they have been notified as the prize winner. This must be provided in writing to School of Medicine and Psychology no later than 30 days from notification.

If the prize is accepted by the recipient, they agree to the Publication of their name.

In some instances the recipient may be asked to:

- 1) write a letter of thanks to the donor;
- 2) participate in marketing activities and/or asked to provide a reflective statement.

#### 5. REVIEW OF PRIZE

The award will be reviewed:

- (a) at the conclusion of the period outlined in section 1; or
- (b) if any eligibility requirements are to be amended
- (c) after 3 years whichever is earliest.

#### 6. VARIATION TO CONDITIONS OF AWARD

In exceptional circumstances and on a case-by-case basis, these conditions of award may be varied by the Director of the ANU Medical School on the recommendation of the Professor of Obstetrics and Gynaecology.
